1. Who we are

2. The information we collect about you

We will hold:

- Data to identify you, including contact details;
- Certain identifiers such as payment card details;
- Information which you have consented to us using; and
- Other information such as telephone recordings, and CCTV images.
- 3. How we collect information about you

We collect information in a number of ways:

- i. Information you give us;
- ii. Information from your use of our products & services;
- iii. Information from your use of our website or and mobile apps; and
- iv. Information provided to us by third parties.

4. How we use your information

We use and share your data where:

- ✓ You have agreed or explicitly consented to the using of your data in a specific way you may withdraw consent at any time;
- Use is required in relation to a service or a contract you have entered into, such as making reservations or securing payment;
- ✓ Use is necessary because we have to comply with a legal obligation;
- ✓ Use is necessary to protect your 'vital interests' in certain circumstances;
- ✓ Use is for our 'legitimate interests, such as managing our business]
- To inform you of our services

5. How we keep your information safe

We know that you care about how your information is used, stored, and shared. We at The Fitzwilliam Hotel take appropriate measures that comply with the relevant laws and the GDPR. - 5. Obtain a portable copy of your information;
- 6. To withdraw consent, where processing is based on consent.
